- INSTRUCTIONS -

The Certification of No Rent Collected (Notice) provides property owners with the ability to request more than two (2) Temporary Exemptions (T1 and/or T3) per calendar year. The Notice must:

- Only use for exemption request for more than two (2) units within the one Assessor Parcel Number (APN);
- Reflect the occupants and actual unit(s) that will not have rent collected for the full calendar year (January-December);
- Valid Public Notary seal, date and signature; and,
- Submitted to the Los Angeles Housing + Community Investment Department's Billing and Collections Unit
